

## COOPERATION AGREEMENT

### Between Gotland Municipality and Beryslav Urban Territorial Community

**Date:** January 1, 2026

---

#### 1. Purpose

This Cooperation Agreement is entered into by and between **Gotland Municipality** and **Beryslav Municipality** (collectively referred to as the "Parties") to express their mutual interest in exploring opportunities for cooperation and collaboration in the following areas:

- Municipal Services
- Culture
- Tourism

The Parties intend to work together in good faith to identify and develop projects and initiatives of mutual benefit, in accordance with their respective policies, priorities, and available resources.

---

#### 2. Scope of Cooperation

The Parties agree to explore cooperation in the following areas, as mutually agreed upon:

- Development of joint projects and best practices,
- Exchange of information about the history and heritage of communities
- Museum/exhibition knowledge
- Joint online work meeting

The specific activities, timelines, and resources committed to any cooperation will be determined by separate written agreements between the Parties.

### 3. General Principles

- **Voluntary Participation:** Participation in any activity under this Cooperation Agreement is voluntary and subject to the availability of resources and mutual agreement.
- **No Legal Obligation:** This Cooperation Agreement does not create any legal obligations or financial commitments for either Party. Any binding commitments will be set forth in separate, written agreements.
- **Good Faith:** The Parties will act in good faith and with mutual respect in all discussions and activities related to this Cooperation Agreement.
- **Confidentiality:** The Parties agree to treat any confidential information exchanged in the course of their cooperation with appropriate care, in accordance with their respective policies.

---

### 4. Implementation

- The Parties may establish working groups or designate points of contact to facilitate communication and coordination.
- Any specific projects or initiatives will be subject to the approval of both Parties and documented in separate agreements.

---

### 5. Duration and Termination

- This Cooperation Agreement will come into effect upon signature by both Parties and will remain in effect for a period of three years, unless terminated earlier by either Party.
- Either Party may terminate this Cooperation Agreement at any time by providing 30 days' written notice to the other Party.

---

### 6. Amendments

Any amendments to this Cooperation Agreement must be made in writing and signed by both Parties.

---

## 7. Miscellaneous

- This Cooperation Agreement is not intended to create and does not create any legal rights or obligations enforceable in a court of law.
- This Cooperation Agreement does not constitute a partnership, joint venture, or agency relationship between the Parties.
- This Cooperation Agreement is non-binding nature and is expressly acknowledged by both Parties.
